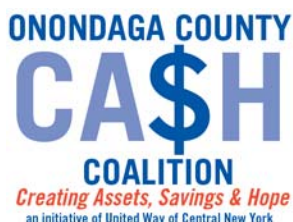

YOU QUALIFY IF:

- ✓ You had Income from wages, self-employment, or government benefits in 2015
- ✓ You do not own Rental Property
- ✓ You did not declare Bankruptcy in 2015
- ✓ You did not receive Military Pay
- ✓ Your 2015 Interest Income was less than \$3,300
- ✓ If you are self-employed, you did not have employees and your business expenses were less than \$10,000, & do not have inventory

WHAT TO BRING:

- ✓ Picture ID for you (and your spouse if filing jointly)
- ✓ Social Security Cards & Birthdates of everyone you are claiming or **individual Tax Payer ID # (ITIN)**
- ✓ Proof of Foreign Status if applying for an **ITIN**
- ✓ W-2 Forms [**Wage & Earning statement(s)**] from all 2015 jobs held
- ✓ 1099-R, 1099-Misc. from all employers
- ✓ Interest & dividends statements from banks (forms 1099)
- ✓ Federal and State Tax Returns from 2014, if available
- ✓ Total paid for Daycare and Daycare's Tax ID # (providers Social Security # or business employer ID #)
- ✓ Form 1095-A if you got health insurance from marketplace/exchange in 2015
- ✓ **For faster return:** Savings and/or checking account routing numbers or blank check for direct deposit
